Payment must be received by LFWD by the date listed on the bill or within twenty-five (25) days of JVWD's receipt of the bill, whichever is later. In the event JVWD fails to make payment within the later of the due date listed on the bill or twenty-five (25) days of their receipt of the bill from LFWD, LFWD may charge a late payment charge pursuant to Chapter 870 of the Commission's Rules and Regulations.
