METER RATES

AVAILABILITY: This rate is applicable to all annual meter services.

MINIMUM CHARGE: The minimum charge for different sizes of meters will be billed on either the quarterly or seasonal basis in accordance with the District’s billing procedure. Temporary or seasonal vacancy shall not be cause for abatement of minimum charge. Minimum charge shall be as follows:

PUBLIC FIRE PROTECTION

AVAILABILITY: To the town of Harrison and village of North Bridgton (Town of Bridgton) for municipal fire protection.

RATES: These rates are calculated as 30% of the total water revenues of the District. They are apportioned 47.5% to Bridgton, for North Bridgton, and 52.5% to Harrison, based on all water Revenues, except public fire protection, for the year ended December 31, 2010.

**AVAILABILITY:** To all consumers using Harrison Water District service for private fire protection. The following rates apply to fire protection service only and include no allowance for other than fire fighting purposes.

**RATES:** Per inch of diameter of fire service pipe per year.  
\$87.62/inch.

**TERMS OF PAYMENT:** All private fire protection charges are payable quarterly in advance.
