General Metered Service

Applicable to the use of water supplied through meters in the territory serviced by the Authority.

The amount of a customer's bill for a billing period will be the total of consumption and fixed service charge. All water services shall be metered.

Quarterly Billing

First 500 cu. ft. or less	\$ 50.43
In excess of 500 cu.ft. per quarter	\$ 4.32 per 100 cu.ft.

If billed monthly, consumption steps and the Minimum Charge will be one-third of the quarterly rate.

In the absence of consumption history or meter readings, quarterly charges are based on the following:

Meter Size	Allowance Quarterly	cu.ft. Monthly
5/8"	1,200	400
3/4"	1,800	600
1"	3,000	1,000
1-1/2"	6,000	2,000
2"	9,600	3,200

Bills under these rates are net in advance and due and payable when presented.

PUBLIC FIRE PROTECTION

Availability

To the Town of Ashland for municipal fire protection.

Rates

For the existing public hydrants as installed April 1, 2018, a fire protection charge of:

\$ 51,600.00	Annually, or
\$ 12,900.00	Quarterly, or
\$ 4,300.00	Monthly

Rates for hydrants installed after April 1, 2018, shall be determined in accordance with the Public Utilities Commission Rules Chapter 69.

All public fire hydrants now existing or to be installed will be cared for and maintained in good working order {unavoidable accidents excepted} by the District. Once any fire hydrant is actually installed and in operation, the total annual fire protection service charge then in effect will not be reduced should the municipality serve order one or more hydrants discontinued.

Should the municipality order any hydrant or hydrants moved to a different location, the municipality shall pay to the District all costs of removing and re-installing said hydrant or hydrants.

Terms of Payment

Charges under these rates are net and may be rendered in advance, annually, quarterly or monthly at the discretion of the District. Bills are due and payable upon presentation.

PRIVATE FIRE PROTECTION

Availability

This rate is applicable to all private automatic sprinkler and private fire services.

Rate

Each private hydrant furnished, installed and maintained by the user for private fire protection.

Private fire service for automatic sprinklers, standpipes, or hose connections to be used only for fire protection inside of buildings.

For each fire hydrant installed on the owner's premises	\$330.93 annually, or \$ 82.73 quarterly

For each service main entering a building for the supply of standpipes or sprinklers, an annual charge according to diameter of the service	\$ 55.15 annually per inch, or \$ 13.79 quarterly per inch

Terms of Payment

Charges under these rates are net and may be rendered in advance, annually, quarterly or monthly at the discretion of the District. Bills are due and payable upon presentation.
