SECOND REVISION

All classes of consumers, except those for which other service is specified in the following schedule, will be supplied with water only on a metered basis. Each meter will be billed separately and be subject to the regular minimum charges specified for the size of the meter.

In cases where more than one meter is used per service, each meter will be subject to the regular minimum charge specified. Consumption charges, however, will be computed on the combined use through all meters.

### Consumption Charges:

For the first	1,200 Cu. Ft. or less	\$66.99
For the next	4,800 Cu. Ft. per quarter	\$3.16 per 100 cubic feet
For the next	24,000 Cu. Ft. per quarter	\$2.55 per 100 cubic feet
For all in excess of	30,000 Cu. Ft. per quarter	\$1.14 per 100 cubic feet

If billed monthly, consumption steps and the Minimum Charge will be one-third of the quarterly charges.

### MINIMUM CHARGES

For each customer served through a single meter, there shall be a minimum charge, based on the size of the meter installed:

## PRIVATE FIRE PROTECTION SERVICE RATES

### AVAILABILITY:

This schedule is available for private fire protection purposes only upon application to and approval by the Department. No connection for other fire protection purposes will be allowed from a fire service, and no unauthorized waer use will be permitted.

### RATE:

For the first private hydrant installed on each lead or service without a sprinkler connection there shall be a charge of: \$83 per month

For each additional hydrant installed on such a lead or service and for each hydrant installed on a service with a sprinkler connection in excess of the maximum number of hydrants allowed without additional charge, as specified above, there shall be a charge of: \$55 per month

Fire Connections will not be supplied on a seasonal basis.

## PUBLIC FIRE PROTECTION

### Available:

For the public hydrants owned and maintained by the Department and connected to the Department's mains on July 1, 2020, there shall be paid to the Department the following public fire protection service charge:

<u>Per Month:</u>	\$14,559	<u>Per Year:</u>	\$174,707
-------------------	----------	------------------	-----------

For each public fire hydrant owned and maintained by the Department and installed after July 1, 2020, charges will be governed by Chapter 69 of the Public Utility Commission Rules and Regulations.

All public fire hydrants now existing or to be installed will be cared for and maintained in good working order (unavoidable accidents excepted) by the Water Division. Once any fire hydrant is actually installed and in operation, the total annual fire protection service charge then in effect will not be reduced should the municipality served order one or more hydrants discontinued.

Should the municipality served order any hydrant or hydrants moved to a different location, the municipality served shall pay to the Division all costs of moving said hydrant or hydrants.
